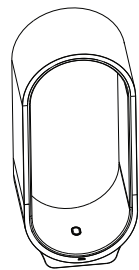

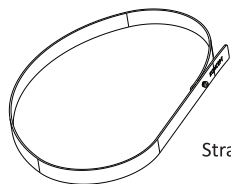

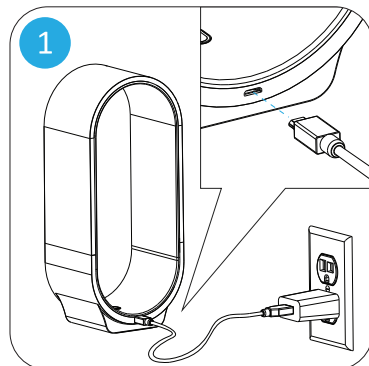

USB charger & cable

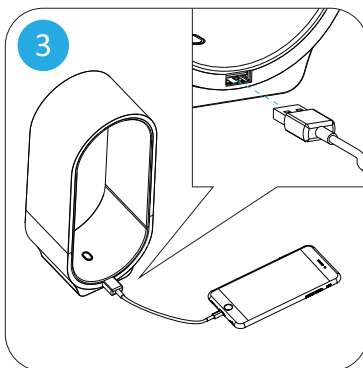


Strap

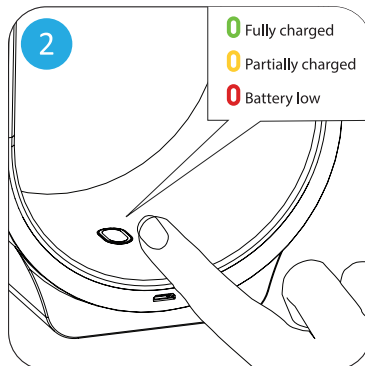


Connect the USB cable & charger to the mr.GO! and start charging. The indicator light will be pulsing green when it is charging. Once it is fully charged the indicator will be off.

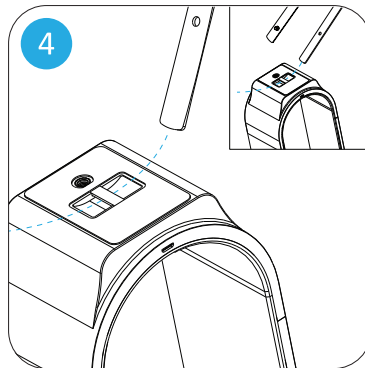
***mr.GO! must be connected to power before first use.**



Charge your phone with the USB port.

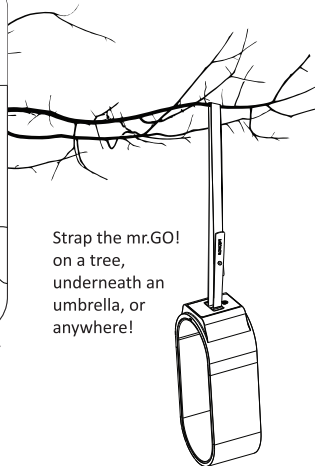


Press the button to turn mr.GO! on or off, or hold it to dim/brighten the light. Press once to have battery indicator light show for 5 seconds.
